- All procedure and investigation fees include specialist charges, diagnostic pathology, consumables local anaesthetic and pathology where relevant.
- When more than 1 procedure is undertaken any extra procedures will be charged at 50% of the normal standalone rate
- Consultation fees are charged separately.
- These are standard charges but some may vary according to agreements with medical insurance companies
- Patients paying for their own treatment, resident overseas or with non UK based insurers will be expected to settle charges in full on the day.
- Patients insured with UK based insurers will be required to provide a membership and pre- authorisation number for the invoices to be submitted directly to their insurer.
- Patients with medical insurance will remain liable for all charges until settled and will be asked to pay for invoices not settled within 3 months in addition to any policy excesses or items not covered by their insurer.
- MRI investigations are not undertaken at 108 Medical Chambers
- In-patient surgical procedures are billed in accordance with insurance company guidelines and patients will be provided with the CCSD code to gain pre-authorisation for the procedure and admission from their insurers. Self pay patients will be provided with a fee estimate in advance of the procedure to cover surgeon, anaesthetist and hospital charges.
